

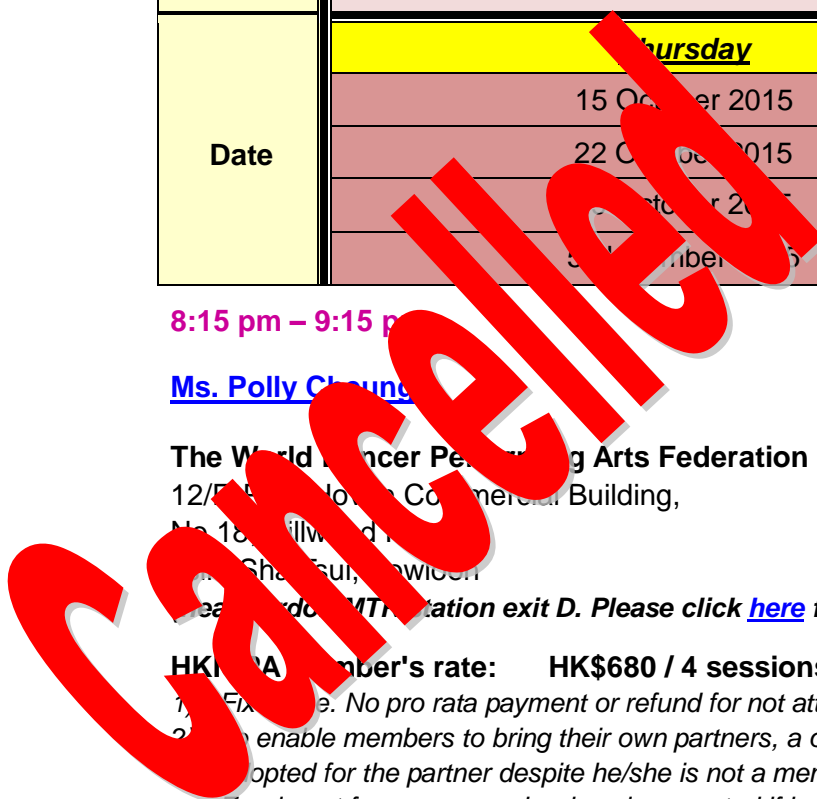
Cha Cha Cha by Polly Cheung
