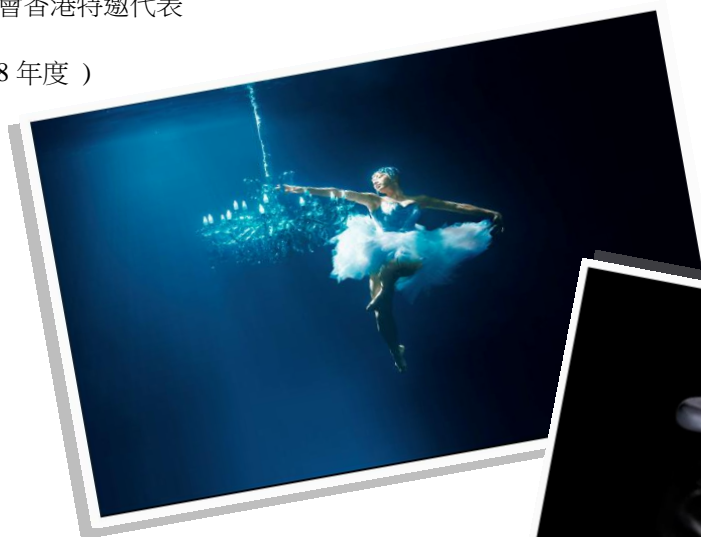

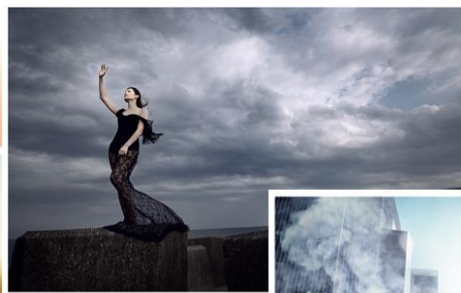


金永峯 *Raymond Kam*
