Accountants' role in combating money laundering and terrorist financing

About the seminar

Accountants, lawyers and other designated non-financial businesses and professions (DNFBP) play an important role in the international fight against money laundering and terrorist financing. The international anti-money laundering (AML) body, the Financial Action Task Force (FATF) looks to DNFBPs as the first line of defence against this form of criminal abuse of the financial system. With the enactment of the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance in 2011, Hong Kong will be expected to introduce similar AML legislation covering customer due diligence and record-keeping for DNFBP, including accountants.

This seminar, one of a series initiated by the Security Bureau for DNFBP, aims to:

- Provide an overview of the latest AML developments in Hong Kong and internationally.
- Enhance understanding of the statutory obligations and practices of suspicious transaction reporting.
- Provide a forum for discussion of matters of common concern on AML compliance and reporting.


