打擊清洗黑錢及恐怖分子融資活動 – 會計師的角色

About the seminar

Accountants, lawyers and other designated non-financial businesses and professions (DNFBP) play an important role, alongside financial institutions, in the international fight against money laundering and terrorist financing. The anti-money laundering (AML) framework produced by the international AML body, the Financial Action Task Force (FATF), looks to DNFBPs as the first line of defence against criminal abuse of this kind of financial system. Following the enactment of the Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance, Hong Kong will be expected to introduce further AML legislation, on customer due diligence and record-keeping for DNFBP.

This seminar for accountants, one of a series initiated by the Security Bureau for DNFBP, aims to:

- Provide an overview of the latest AML developments in Hong Kong and internationally.
- Enhance understanding of the statutory obligations and practices of suspicious transaction reporting.
- Provide a forum for discussion of matters of common concern on AML compliance and reporting.
