夏威夷小結他(英語:Ukulele; 又翻作尤克裡裡、烏克麗麗)，簡稱 Uke，是一種夏威夷的撥弦樂器，歸屬在結他樂器一族，通常有四條弦。Ukulele 分成高音(Soprano)、中音(Concert)、次中音(Tenor)與上低音(Baritone)四種尺寸，其中以 Soprano 及 Concert 最為普遍及適合初學人仕。
