Amidst the signing of the Closer Economic Partnership Arrangement between the HKSAR and Central Governments, there are increasing number of Institute's members / International Affiliates and their clients investing or practising in the Mainland. In this connection, the Hong Kong Institute of Certified Public Accountants has entered into an agreement with the Shenzhen Institute of Certified Public Accountants (SziCPA) and set up a "China Desk" service station at the Shenzhen office of SziCPA to provide free advisory services and information to Institute's members / International Affiliates on Mainland related issues.

Scope of Free Services
