The much anticipated annual CPA Singing Contest is open for registration. It will not only offer an opportunity for members to showcase their vocal talents, but also serves as an internal selection process to select members to represent the Institute at the singing contest organised by the Recreation and Sports Club for Hong Kong Professional Bodies.

<b>Awards</b>	Trophies will be awarded to the following winners: <ul style="list-style-type: none"><li>- Champion, 1<sup>st</sup> and 2<sup>nd</sup> runner up</li><li>- Best Stage Appeal (最佳台風獎)</li><li>- Most Popular Contestant (最受歡迎歌手獎)</li></ul>
<b>Fee</b>	<b>\$210</b> per contestant <b>\$50</b> per guest [Each contestant can only bring 2 guests due to venue constraint.]



## Format/ Rules

### Format:

- Both the preliminary and final round will be held on 16 November 2013.
- Song selection is subject to the availability of the venue where the competition is held. Requests for song change will not be entertained after enrolment deadline on 25 October 2013.
- Only music will be played during the contest while all visual aids (e.g. screen or tv screen) will be turned off.
- Each contestant will sing one song of their choice at the preliminary round. The 8 contestants with the highest scores in the preliminary round will advance to the final.
- Scores from the preliminary round will not be carried over to the final round. Final results will only be based on scores obtained in the final round.
- The 3 contestants with the highest scores in the final will be awarded champion, 1<sup>st</sup> runner-up and 2<sup>nd</sup> runner-up respectively.
- The "Most Popular Contestant" award will be voted by all contestants, while the "Best Stage Appeal" will be voted by the judges.

### Rules:

- All contestants must specify the singer of the song that they choose for the preliminary round.
- Finalist can only select a song from a repertoire of 8 songs pre-selected by the organiser for the final round.
- Only MTV version of a song is accepted and used for the contest. Concert version is not accepted.
- No visual aids are allowed for the entire contest. Contestants are expected to memorise all the lyrics.
- Each contestant must provide a copy of the lyrics for the judges' reference.
- Contestants cannot alter the echo of the microphone.
- In the event of any disputes, the decision of the judges shall be final.
