In advisory services he has been involved in product design and development, accounting treatment and policy, governance and Shariah review as well as risk analysis and solutions for Islamic Financial Services Board. He has also completed both national and international research for Islamic financial services industry that provides policy direction on the future development of the industry.

Dr. Syed is also an Associate Professor and the Deputy Dean of the Graduate School of Business, University Tun Abdul Raza. In University Tun Abdul Raza, he had served as Dean, Faculty of Business Administration and Head of Center for Graduate Studies. He taught accounting and finance courses for both academic and professional programs, including Master and Doctoral degree courses in accounting theory and policy, Islamic accounting and finance, accounting for Islamic financial institutions and financial management, in both public and private universities.

Dr. Syed obtained Doctor of Business Administration (1994) (Accounting and Finance) from Strathclyde University, UK.
