**Highlights** You are able to know more about the new business opportunity under the Capital Investment Entrant Scheme (“[Scheme](#)”) which was introduced by the Hong Kong Immigration Department (“HKID”) on 13 March to shorten the processing time for applications submitted under the Scheme.

Under the new arrangement, the Scheme applicants may engage a [CPA \(Practising\)](#) to issue a report to demonstrate that they meet the net assets or net equity requirement of not less than HK\$6.5 million net throughout the two years preceding the date they lodged their application.

An Immigration Officer (Other Visas and Permits Section) from HKID will attend the Forum to explain to members about the Scheme and answer questions from members.

The Institute has worked closely with the HKID to develop [guidance](#) for CPA (Practising) in taking up this work. You may raise any questions on this guidance.
