中國書法課程

楷書-魏碑

-劉才昌先生,香港中國書法家協會會長



課程內容

魏碑為魏晉南北朝碑刻字體的統稱，是由隸書演變而來的一種楷書。由於其筆力方勁、型態質樸而風靡當時整個北方，其代表字帖有〈張猛龍碑〉、〈鄭文公碑〉及〈石門銘〉等。時至一千多年以後的今天，魏碑依然因為其質樸有力而深受當代人的喜愛。

本課程共三十堂，分上、下兩段各十五堂，上段以基礎訓練為主，下段主要為創作訓練。

導師履歷

劉才昌先生 一九三六年生，是當代最著名的十大書法家之一，當代藝術大師劉海粟的入室弟子。現任香港中國書法家協會會長，香港中國書法研究所所長，香港美術家協會書法委員會主席，中國書畫函大教授。一九五五年考入北京大學，在大學教授二十餘年，並在香港及國內多家電視台主講書法藝術。其作品入選〈當代中國書法作品集〉、〈當代書法藝術大成〉、〈中國當代著名書法家百人精品集〉、〈全國首屆著名作家、詩人、書法家、畫家聯展作品集〉、〈香港名家書法展集〉等，名列〈中國美術年鑑〉、〈中國古今書畫名人大辭典〉、〈中國當代書法家辭典〉、〈中國當代書畫家名人大辭典〉、〈中外名人辭典〉、〈中國當代名人錄〉、〈香港名人錄〉等。中國郵政曾為其出版發行書畫藝術專題郵票，共十六枚。



劉先生不僅勤於耕耘，而且教書育人，桃李滿門。前香港新華社社長周南先生、副社長張浚生先生、前律政司司長羅德丞先生以及曾任全國政協香港召集人的陸達權先生等，都是劉先生的學生，近年來，多個香港專業協會請劉先生主講書法課程，學員有幾百人之多。

鑑於劉先生在當代中國書畫界的重要地位及先生為弘揚中國書畫藝術的卓越表現，具有二百多年歷史的佳士得香港拍賣行，近年多次成功拍賣劉先生的書法作品，具有最頂級公信力的文物出版社也會在今年為劉先生出版書法專著。
