The **Singing Interest Group (SgIG)** has organised a concert with live band for members to gain experience in stage performance in front of a large audience. The programme will include solo, duo or group performances. Audience admission is *free* so bring your friends and family to enjoy an evening of music spectacle.

**Performer's fee:** **\$420** per song (with up to 10 free admission tickets)

**Admission tickets:** **Free** (To allow more people to enjoy the concert, we will charge ticket holder \$30 for any unused ticket.)

## Notes for performers

1. Performer's registration is on a first-come-first-served basis.
2. Those who intend to perform 2 songs are advised to perform one solo and one duo/group to enrich the program.
3. Each performing song should not be more than 5 minutes.
4. No medley or concert version is allowed.
5. In the event of song duplication, involved parties will be invited to re-select their songs. Once the performance songs are confirmed, no further changes will be entertained.
6. NO visual aid will be provided during performance.
7. Each performer/performing unit is entitled up to 10 free tickets.
8. Rehearsal session is available on the same day prior to the concert with details to be announced. Due to limited time available on event day, each performing unit will be given approximately 3 minutes to rehearse.
9. All performers are required to attend the rehearsal session with live band on **11 September**.

3. To ensure the success of the concert, \$30 will be charged to each unused ticket after the concert. Tickets can be returned to us **by 19 September** for the benefit of those on waiting list. Returned tickets are not subject to any fee charging.
4. The closing date for performance registration is **28 August 2016**. However, the Institute has the discretion to accept late applications as it sees fit.
5. Application by fax will **ONLY** be accepted when payment is made by credit card. Cheque payment must be made together with the registration form. Cash is strictly **NOT** accepted for all Institute registration.
6. Successful registrants will receive confirmation by email, whereas unsuccessful registrants will receive full refund by mail.

8. Unless the activity is cancelled due to unforeseen circumstances, bad weather or low enrolment, no refund for withdrawal will be entertained after your enrolment has been processed.

Your enrolment fee will be refunded in full in the event of cancellation due to bad weather, or subject to separate arrangement with the venue provider.
