Format:	 Each team will comprise of 3 players, out of whom at least two players must be HKICPA members. Each team can have a maximum of 3 reserves listed on the team's roster throughout the league and they can be non-HKICPA members. A total of 14 sessions will be held in the league season. Each player plays 3 games with handicap in each session. At least half of each team's league games, i.e. 63 out of 126 games (3 games x 3 players x 14 sessions), must be played by HKICPA members. Detailed league rules will be distributed to registered players. (* To comply with the lane booking requirement, at least one member of each team needs to be a current member of SCAA. If none, one of the teammates has to join SCAA membership at his own cost at HK\$100 for ordinary member.)
