## About the competition



The competition is divided into two categories:

**Latin: Cha Cha Cha & Rumba**

**Ballroom: Waltz & Tango**

- Members interested to enter into the competition should submit the competition registration form with particulars of his/her partner, who can be a non-member.
- A contestant can join more than one category with different partner.
- As this is a competition for members and their score will take up the majority of the total score. There is no restriction on gender for competition entry. In other words, a couple can be in the same gender or different gender.
- There is no fixed choreography or syllabus. Judges will look for members' posture; timing; line; hold; poise; musicality and expression; foot and leg action; lead and follow and floor craft. Judges' decisions are final and no appeal will be entertained.
- The duration of each dance is approximately 2 minutes.
- The entire competition including prize presentation will take place at the Dance Fun Night on 12 September. First, second and third place will be awarded with trophies/medals.
- No entry fee is required to enter into this members' competition.
- Deadline for entry is **21 August 2015**.
- The competition will be cancelled if there are less than 4 entries for each category. Subject to the final number of entries, the competition may be divided into preliminary and final rounds to be held in the same evening.

3. The closing date for enrolment is 24 August 2015. However, the Institute has the discretion to accept late applications as it sees fit.

5. Unless the event is cancelled due to unforeseen circumstances, no refund for withdrawal will be given after the enrolment has been processed.
