#### About the programme and instructor

一首歌曲的完美表達,就是音樂和語言的結合,歌唱訓練並不單純是掌握聲音技巧,還必須把握語言規律,這樣才能在歌唱中既表現聲音的魅力和語言魅力,達到聲音美與語言美的統一。

課程主要針對兩部分,包括基礎練習及歌曲演繹。

#### 1.基礎練習

**音階練習** - 利用不同咬字配合,讓學員發掘發聲位置;擴展個人音域,加強發聲及音準基本功。

**呼吸運用** - 讓學員懂得正確呼吸方法及有關肌肉配合,以改善歌唱時「唔夠氣」的情況。

**吐字技巧** - 每個字都是由一個音節組成的,而一個音節又可以把它分成字頭、字腹、字尾三部分,這三部

分從語音結構來分。要想做到吐字清晰就要從這三方面入手加以訓練,不再成爲歌唱發聲的障

礙。

### 2.歌曲演繹

加強學員對歌詞、旋律及節奏的感悟。在深刻理解歌曲以後,更宜於表達情感。學員透過交流及分析,令學 員加深了解自己不足之處繼而改善及進步,達致完美歌曲演繹。

#### 課程特色

- 本課程無需任何歌唱經驗,適合初學人士。
- 完成 Cycle 1 及 Cycle 2 課程後將可於 Music Stage 舞台參與演出 Carol's Singing Student Mini Concert,享受實際舞台經驗。
