



# What accountants should do to combat money laundering and terrorist financing

## 打擊清洗黑錢及恐怖分子融資活動 – 會計師的角色

### About the seminar

The international anti-money laundering ("AML") body, the Financial Action Task Force ("FATF"), expects accountants, lawyers and other Designated Non-Financial Businesses and Professions ("DNFBP") to play an increasingly important role, alongside financial institutions, in the fight against money laundering and terrorist financing. As one of the world's major financial centres, Hong Kong needs to safeguard its financial system against criminal abuse of this kind. Legislation to give statutory backing to customer due diligence and record keeping requirements for AML purposes is being introduced in Hong Kong - currently for financial service providers and later for DNFBP.

In this seminar, Hong Kong SAR Government Security Bureau and Institute representatives will explain and discuss the role of accountants in AML. This is one of a series of seminars initiated by the Security Bureau for DNFBP, which aim to:

- ✓ Provide DNFBP with an overview of the latest international and domestic AML developments.
- ✓ Enhance understanding of the statutory obligations and practices of suspicious transaction reporting.
- ✓ Provide a forum for discussion of matters of common concern on AML compliance and reporting.
