Mr. Kwok, Assistant Secretary (Narcotics) of the Security Bureau, joined the civil service in 1990 and has served in a number of policy bureaux and departments, including the Home Affairs Bureau, the Financial Services and the Treasury Bureau and the Industry Department. He assumed the current post in early 2007 and has participated actively in the Financial Action Task Force on Money Laundering/Asia Pacific Group on Money Laundering's Joint Mutual Evaluation of Hong Kong, China, in particular parts relating to the non-financial sectors.

Stewart McGlynn, Detective Chief Inspector, Joint Financial Intelligence Unit Mr. McGlynn joined the Hong Kong Police in 1994, engaging in investigating duties in Divisional, District, Regional and Force level crime units since 1995. During his career, Mr. McGlynn has been the lead investigator and officer in charge of a number of large prosecutions including complex commercial frauds and multiple homicides. Mr. McGlynn is currently the deputy head of the Hong Kong Joint Financial Intelligence Unit (JFIU). His core responsibilities include the current expansion of the JFIU, strategic intelligence, international liaison and the continued development of the Hong Kong Police's financial training and outreach programs.
