《中國會計年鑒》2017年卷的內容主要涵蓋2016年度國家、行業(部門)、地方和企業的財務會計工作、註冊會計師工作、資產評估工作、會計理論研究、會計教育、重要法規、財會統計資料、會計組織機構和人員、會計大事記等。年鑒附有光碟,方便讀者查閱。
