About the seminar

The international anti-money laundering body, the Financial Action Task Force ("FATF"), expects accountants, lawyers and other Designated Non-Financial Businesses and Professions ("DNFBP") to play an increasingly important role, alongside banks and other financial institutions, in the fight against money laundering and terrorist financing. As one of the world's major financial centres, Hong Kong also needs to safeguard its financial system against criminal abuse of this kind, and legislation is in the pipeline to implement key FATF requirements. In this seminar, Hong Kong SAR Government and Institute representatives will explain and discuss what accountants should do to prevent money laundering and terrorist financing.

This forum is one of a series of anti-money laundering ("AML") seminars organised by the Security Bureau for DNFBP, the objectives of which are:

- ✓ To provide DNFBP with an overview of the latest international and domestic AML developments.
- ✓ To enhance understanding of the statutory obligations and practices of suspicious transaction reporting.
- ✓ To provide a forum for discussion of matters of common concern on AML compliance and reporting.
