



Mainland Business Interest Group Circular (Issue 9/2006)



A HKICPA/HKTDC joint seminar on "Mainland Labour Law (I) " will be held on 20 June. Officials from the Guangdong Provincial Labour and Social Security Department (廣東省勞動和社會保障廳) will provide an update on the regulations relating to recruitment, employment contract, social security, labour disputes, etc. in the Mainland. The admission fee is \$200 and 2 CPD hours will be awarded. A flyer containing the details is attached for your attention. Workshops on PRC Accounting, Auditing, Taxation, Capital Market and Corporate Governance (Jul 2006)

中國會計、審計、稅務、資本市場與公司管治課題工作坊

CONTENTS

The course is designed for accountants who wish to acquire a comprehensive understanding of the PRC investment environment. Encompassing five major components of study on PRC Accounting, Auditing, Taxation, Capital Market and Corporate Governance, the course will be delivered in the form of 13 three-hour workshops on Saturdays. Specifically, the outline objectives of these components are:

- PRC Accounting Workshops cover the PRC accounting regulatory framework; accounting for assets, liabilities, equities, profit and loss item and other accounting adjustments; financial accounting reports; performance evaluation; consolidated accounts and business combination; financial statement case study and other contemporary accounting issues in China.
- PRC Auditing Workshops examine the development of auditing profession and auditing standards, as well as the issues relating to auditors' independence and liabilities in China.
- PRC Taxation Workshops cover an overview of the current tax regime; Individual Income Tax; Foreign Investment Enterprise and Foreign Enterprise Income Tax; Business Tax; Value Added Tax, transfer pricing and other PRC tax planning strategies.
- PRC Capital Market Workshops examine the development of stock markets and investment fund markets in China.
- PRC Corporate Governance Workshops examine the corporate governance framework and related issues for the listed companies in China.
