4. Administrative expenses

- c. Any personal expenses such as, but not limited to, long distance calls, use of hotel facilities with charges, laundry, sight-seeing and other entertainment which are not mentioned in the circular.

The visit is subject to the following conditions:

- i. The visit will be cancelled if less than 10 PICIG members enrolled in the visit.
- i. Train ticket is on a fixed-departure time, non-endorsable, non-refundable and non-reroutable basis. Therefore, no alternative arrangements on train ticket and hotel are permitted.

Members who wish to apply for the visit should complete the Application Form and return it to the Standards & Technical Department of the Society for registration. You may send the Application Form by fax first, to be followed by mail together with a cheque payable to "Hong Kong Institute of Certified Public Accountants" on or before Wednesday, 14 April 2004. Please register early to avoid disappointment.
