About the heritage ◆

- The Center at the Hong Kong Jockey Club Former Explosives Magazine combines new construction with four former military buildings, three of which are listed as Grade 1 Historic Buildings and are part of the Former Explosives Magazine Compound. The compound was an integral part of the British military lands and as one of the few remaining sites, it is an important tangible link to Hong Kong's past.
- ♦ The former Explosives Magazine Compound was built by the British Army in the mid-19th century to prepare and store explosives. Within this site, gunpowder was processed, packaged, stored, and issued to defensive locations throughout Hong Kong. In the beginning of the 20th century, the site was expanded and taken over by the Navy. By the middle of the 20th century, it was used by the British Government as storage space until it became a depot in the 1970s. After the 1980s, the site was not used until it was granted to the Center by the HKSAR Government for adaptive reuse.
