The **Bowling Interest Group (BoIG)** cordially invites you to join its "Winter League" which will start from November 2014 to February 2015. We accept team entry and individual entry. For the latter, the group will be decided by the secretariat.

- Dates:** 7 November 2014 to 6 February 2015 (all Fridays)
7, 14, 21 & 28 November; 5, 12 & 19 December
9, 16, 23 & 30 January; 6 February
- Time:** 8:00 pm – 10:00 pm (starts promptly at 8:00 pm.)
- Venue:** South China Athletic Association Bowling Centre (SCAA)
- Assembly time and place:** 7:30 pm at Section A area of SCAA for the first session of the league
- Fee:**
- \$1,560 (HKICPA member); \$1,650 (non-HKICPA member) for 12 sessions
 - no pro rata payment is accepted.
 - \$8 for shoes rental per session.
- No. of team:** Min 8 teams (max 10)
- Format:**
- Each team will comprise of 3 players, of which at least 2 are HKICPA members. A team can have a maximum of 3 reserves listed on the team's roster who can be non-HKICPA members.
 - A total of 12 sessions will be held. Each player plays 3 games with handicap in each session.
 - There must be at least 1 HKICPA member playing in the team in each session, or an equivalent of at least 3 games played by HKICPA members.
 - At least half of each team's league games, i.e. 54 out of 108 games (3 games x 3 players x 12 sessions), must be played by HKICPA members.
 - Detailed league rules will be distributed to registered players.
- (* To comply with the lane booking requirement, at least one member of each team needs to be a current member of SCAA. If none, one of the teammates has to join SCAA membership, whose annual fee is HK\$100 for ordinary member.)*

- Team champion, 1st runner-Up and 2nd runner-up.

 - Individual best improved players.
 - Weekly high game winners.
