### Notes for performers

- Each performing unit can perform up to 2 songs (max 10minutes), subject to the total number of performers.
- For group performance, one of the performers must be a HKICPA member.
- By <u>10 August</u>, all performers must submit their performing songs (at least 3) to the secretariat. If there are duplication, involved parties will be asked to reconsider their selections. Once the performing songs are confirmed, no further changes are allowed.
- Each performing unit must prepare their own music in <u>MMO/CD format</u>. The recording (one song per disc) must not contain a long introduction to save time. Therefore, VCD/DVD Karaoke versions are <u>not</u> accepted. All recording must reach the secretariat by <u>22 August</u>.
- NO television screen will be provided during performance.
- Each performing unit is entitled to 10 free tickets.
