### About the programme and instructor

音樂劇-是在戲劇中藉著歌曲來交代劇情發展,以及表達角色心中的情感的一種表演模式,而此演出模式所要求的演唱技巧是與流行歌所不同的,需要時而強而有力,時而溫柔委婉,獨唱時能有壓台感,合唱時亦與其他演員混為一體,亦需要小心的分析樂曲結構與利用深沉的呼吸來演唱高難度的歌曲-而演唱音樂劇的技巧對於演唱任何類型的歌曲亦能有效幫助發揮。

此課程分為兩部分一分別是音樂劇演唱技巧及演繹班及基本樂理及讀譜工作坊。

### 音樂劇演唱技巧及演繹班

### 課程重點:

- i. 了解我們的身體與聲音的關係-身體是我們聲音的共鳴箱,使用得宜的話便可以達致更好的聲音投射(Projection)來產生更悅耳及強而有力的聲音。
- ii. 呼吸控制及運氣練習-為何唱歌劇的人能以響亮的聲音演唱連綿不斷的長音但我們卻很容易覺得不 夠氣?其實,我們的肺部容量是很大的,但一般人都只會用了我們肺部的三成容量-在課堂中,會 以不同的呼吸及運氣練習去學習如何呼吸和增加肺活量,並學習靈活使用腹式呼吸/丹田。
- iii. 以悅耳及情感澎湃的著名音樂劇歌曲來學習如何在歌曲中表達情感及說故事
- iv. 讀譜練習、了解並分析歌曲結構以幫助演繹
- v. 學習演繹歌曲時的咬字及造句
- vi. 感受如何在小組合唱歌曲中和其他歌者交流並達至和諧的效果

課程特色: 適合對音樂劇演繹有興趣及想了解自己聲音更多的朋友。
