- 首歌曲的完美表達,就是音樂和語言的結合,歌唱訓練並不單純是掌握聲音技巧,還必須把握語言規律,這 樣才能在歌唱中表現聲音的魅力和語言魅力,達到聲音美與語言美的統一。

課程主要分為兩部分,基礎練習及歌曲演繹。

1.基礎練習

音階練習 -利用不同咬字配合,讓學員發掘發聲位置;擴展個人音域,加強發聲及音準基本功。

呼吸運用 -讓學員懂得正確呼吸方法及有關肌肉配合,以改善歌唱時「唔夠氣」的情況。

吐字技巧 -每個字都是由一個音節組成的,而一個音節又可以把它分成字頭、字腹、字尾三部分,這 三部分從語音結構來分。要想做到吐字清晰就要從這三方面入手加以訓練,不再成為歌唱發聲的障礙。

2.歌曲演繹




課程特色
