

## Spin-offs – From idea to execution

## About the topic

A number of proposals for spin-off have been announced recently by listed companies. The ultimate outcome is to carve out certain segment(s) of the business and/or assets of the listed group, pack them under a separate entity for a listing on the Hong Kong Stock Exchange or other stock exchanges. But what does this really entail and why are there more activities of this kind these days?

At this seminar, Mr. Yue-Seng Chiu of HSBC, who has extensive capital markets and investment banking experience, will discuss the factors that have been driving the recent trend towards business disaggregation, and strategic and other factors motivating companies to spin off business units. He will highlight the relevant regulatory requirements. The focus will also be on the practical obstacles and pitfalls in structuring and executing spin-offs, as well as relevant factors and conditions that management should take into consideration in making a spin-off decision. Mr. Chiu will share his experience of spin-off success stories and failures.
