As a result of the global financial crisis, governments and regulators are under pressure to tighten rules and strengthen enforcement as a deterrent against poor management or fraudsters. This has a great impact on directors and officers of companies and their service partners. Recent cases of enforcement by regulators in Hong Kong and around the region also have significant implications for the liability of professionals.
