#### ABOUT THE SPEAKER

**Dr. Chiang Hong Man, Michael**, FHKIA, ARAIA, RIBA, AP, is a professional fung shui and destiny consultant, author, columnist and lecturer, who helps people to create harmony with environment for greater health, wealth and prosperity. Dr. Chiang was graduated with honors in a degree in Architecture from University of Hong Kong in 1980 and obtained his Doctorate degree in 2012 all with flying colors. He is a distinguished scholar in Chinese Architecture and garden designs. He is especially accomplished in the ancient science of fung shui and its application in architectural designs.

His recent works included various new town planning projects in Chen Zhou (彬州) Gui Yang country (貴陽縣) and Yu Fu City (雲浮市) in China and the AMP Millennium City in Hong Kong. He also contributed to the discovery of the ancient site of the Pagoda of Bao En Temple and the Buddhas relic in Nanjing, 2008.

He is the author of 7 popular fung shui books in Chinese and a columnist for the Chinese commercial press (香港商報) whose Thursday column wrote commentaries on public subjects related to city planning and architectural matters.
