Trust and Insolvency (Part 1)

About the topic

In this two-part seminar, Ludwig Ng of ONC Lawyers will discuss issues that insolvency practitioners need to deal with arising from trusts, including resulting and constructive trusts. In Part 1, Ludwig will explain how to identify resulting and constructive trusts, thus potentially enlarging the assets of the company in liquidation or the bankrupt; the consequences following identification of a trust; tracing and other proprietary remedies available to insolvency practitioners; and possible claims against other parties involved in breach of trust. In Part 2, to be held in April, Ludwig will discuss how insolvency practitioners should deal with trust claims, or purported trust claims, made against the estate of the wound up company or the bankrupt.

- The proprietary remedies of the beneficiary
- Liabilities of parties assisting breach of trust or receiving trust property
