The Institute's new edition of *A Guide to Quality Control* ("Guide") was issued in June 2013. The Guide focuses primarily on the development of a firm-wide quality control system. This sets the foundation for the existence of appropriate firm policies that should assist and enable the practitioner to implement the engagement-level requirements.

- The workshop aims to introduce the Guide, the general requirements under the Clarified Hong Kong Standard on Quality Control 1 and the common findings under the Practice Review on quality control.
- Sample policies and procedures for different sizes of practice will be introduced in order to develop a customised quality control on a consistent basis
