

HKFRS for Private Entities Workshop

The HKFRS for Private Entities (HKFRS for PEs), based on *IFRS for SMEs* with amendments to suit Hong Kong's circumstances, was issued in April 2010 as a reporting option for eligible private entities in preparing general purpose financial statements.

In 2015, IASB has made limited amendments to *IFRS* for *SMEs*. The Institute has adopted those amendments in HKFRS for PEs which will be effective for annual periods beginning on or after 1 January 2017.

This one-day workshop aims at assisting participants with the application of HKFRS for PEs. It provides an overview and highlight of the existing standard with plenary instruction, exercises and practical guidance on relevant application, as well as a discussion on the 2015 amendments. The contents and training materials of the workshop is based largely on IASB training materials.
