Each session will include short lectures covering key points of the relevant accounting standards and practical case illustrations.

- Prepare calculation of goodwill arising on an acquisition made during the year
- Account for the effects of consolidating subsidiaries whose functional currencies are different from the parent company
 Account for the disposals of an investment during the year
