陳教授畢業於美國 Wesleyan 大學,獲授經濟學學士學位,其後在芝加哥大學 獲授工商管理碩士和財務學哲學博士學位。他專長研究資產定價、交易策略評 估及市場效率,並曾發表不少有關文章。

陳教授曾擔任多項重要公職,包括消費者委員會主席、香港期貨交易所董事、 策略發展委員會委員、扶貧委員會委員、外匯基金諮詢委員會委員、恆生指數 顧問委員會委員及香港學術評審局委員。此外,他曾出任亞太金融學會主席及 亞太商學院聯會主席。



楊書健先生是安泓投資有限公司的投資總監,負責管理公司所有投資項目。楊先生之前是領盛投資管理的亞太區證券部董事總經理,負責管理該環球投資基金的亞太區部份及其分析團隊。楊先生亦是安泓及領盛亞太區證券部的創辦人,在此之前曾於紐約的摩根士丹利及美國運通工作。

楊先生先後獲取美國麻省理工學院多個學位,包括政治學學士、管理學學士、機械工程學及電腦學學士及政治學碩士。他擁有特許財務分析師資格及英國特許管理會計師的資深管理會計文憑。楊先生現任亞洲公共房地產市場聯盟及香港證券及投資學會之講師。
