World's top woman accountant discusses her fight for gender equality

The March issue of A Plus is out now, featuring the IFAC's first female president, implications from the settlement between U.S. SEC and Chinese Big Four accounting firms, a CPA who works in the camper and boater business, one year after the new Companies Ordinance, and team-building ideas for the profession

(HONG KONG, 19 March 2015) – The first female president of the International Federation of Accountants, which oversees 2.5 million accountants around the world, Olivia Kirtley tells *A Plus* that she was almost barred from entering the profession 40 years ago because of the strong prejudice against women that prevailed in the profession.

The managing partner at another firm who had three daughters and was brave enough to go against the status quo gave her a chance, thus rescuing her professional career.

In her interview with the March issue of *A Plus*, she also talks about her responsibility as a role model for women, the bright future of the profession, and other topical issues during her two-year term.

The breakthrough settlement between the United States' Securities and Exchange Commission and Chinese affiliates of the Big Four accounting firms has paved a solid foundation for the future, but also presents challenges for cross-border cooperation on audit regulation. Another *A Plus* feature has more.

The increasing travel and leisure appetite of Chinese consumers is a boon to Sweden's Dometic Group, a manufacturer of appliances for campers and boaters. According to estimates, China will add more than 100 campgrounds to its existing 70, which still has huge room for growth when compared with more than 7,000 in the United Kingdom. The number of recreation vehicles on the road will jump 40 percent year-on-year from 6,000 in 2013 to 28,000 by 2018. The company's Asia Pacific chief financial officer, Eric Yuen, also a member of the Hong Kong Institute of CPAs, explains the company's regional strategy to *A Plus*.

The migration to the new Companies Ordinance regime has been smooth as the usage rate of new forms for submitting incorporation applications was close to 100 percent, according to the Companies Registrar. Some of the more common issues arising from the implementation of the new legislation in its first anniversary are also highlighted in *A Plus*.

Building sandcastles is not just fun, it also brings colleagues closer together and strengthens communication skills that benefit work and life, according to CPAs who have participated in the corporate team-building activity. *A Plus* also looks at how other corporate events, such as mooncake-making and a retreat to Barbados, can lead to more productive office environments.
